- 3. A Transcript of Records will be issued by the receiving institution no <u>later than five weeks</u> after the assessment period has finished at the receiving HEI.
- 4. Termination of the agreement

Termination of the agreement: In whichever case, either party can terminate the Agreement by informing the other party expressly in writing with at least one year's notice. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. Students selected prior the date of notification must be admitted by the receiving institution. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.

1. Grading systems of the institutions

Kocaeli University grading system

At Kocaeli University, one full academic year includes two terms with an ECTS credit of 30 for each. Each course is graded in numbers from 0,00 to 4,00 and these grades are equivalent in ECTS grade and level as follows: 0,00-0,50: Fail (F), 0,50-1,50: Conditional Pass (FX), 1,50-2,00: Sufficient (E), 2,00-2,50: Satisfactory (D), 2,50-3,00: Good (C), 3,00-3,50: Very Good (B), 3,50-4,00: Excellent (A)

San Jorge University grading syste:

The grading system follows both the national regulations and the ECTS guidelines, established in the Spanish Royal Decree 1125/2008.

Course Load per Semester: In average 30 ECTS

Grading:

San Jorge University uses a local grading scale with marks between 0 and 10.

10 reflects the maximum score; 5 is the minimum mark to pass an exam and obtain credits; less than 5 means a failure; «No presentado» means that the student has not participated in the evaluation activities. «Matrícula de Honor» means Excellent, with special mention.
