- A Transcript of Records will be issued by the receiving institution no later than five weeks after the assessment period has finished at the receiving HEI.
- 4. Termination of the agreement

Termination of the agreement: In whichever case, either party can terminate the Agreement by informing the other party expressly in writing with at least one year's notice. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. Students selected prior the date of notification must be admitted by the receiving institution. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.

1. Grading systems of the institutions

Kocaeli University grading system

At Kocaeli University, one full academic year includes two terms with an ECTS credit of 30 for each. Each course is graded in numbers from 0,00 to 4,00 and these grades are equivalent in ECTS grade and level as follows: 0,00-0,50: Fail (F), 0,50-1,50: Conditional Pass (FX), 1,50-2,00: Sufficient (E), 2,00-2,50: Satisfactory (D), 2,50-3,00: Good (C), 3,00-3,50: Very Good (B), 3,50-4,00: Excellent (A)

Grading System of Receiving Institution

Lithuanian Maritime Academy grading system

Lithuanian Maritime Academy uses a criterion-referenced grading system, based on learning outcomes. For exchange students the ECTS grading scale is used parallel with the LMA grading scale. In order to contribute to the understanding of LMA grades, there has been established a set model for translation of the grades to their approximate equivalents in the ECTS scale. One full academic year includes two terms with an ECTS credit of 30 for each. 10-9 (excellent) - A, B excellent, very good; 8-7 (good) - C good; 6 (satisfactory) - D satisfactory; 5 (pass) - E sufficient; Below 4 (fail) - FX, F fail.

2. Visa

The sending and receiving institutions will provide assistance, when required, in securing visas for incoming and outbound mobile participants, according to the requirements of the Erasmus Charter for Higher Education.
